



Club Championship Series 2020-2021

NOTICE OF RACE

The Organising Authority is Jervoise Bay Sailing Club
128 Woodman Point View, Coogee WA 6166

1. RULES

- 1.1. The regatta will be governed by rules as defined in The 2017 – 2020 Racing Rules of Sailing (RRS) of World Sailing, and the Prescriptions of Australian Sailing.
- 1.2. RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.
- 1.3. If there is a conflict between the Sailing Instructions and the Notice of Race, the Sailing Instructions shall prevail, this changes RRS 63.7

2. ADVERTISING

- 2.1. Boats and competitors shall comply with World Sailing Regulation 20, Advertising Code.
- 2.2. Boats and competitors may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.

3. ELIGIBILITY & ENTRY

- 3.1. All competitors must have completed the [Australian Sailing 2017-2021 AS Special Regulations Part 2 Equipment Audit Form \(Off the Beach\)](#).
- 3.2. All Skippers must be financial members of JBSC to be eligible for Championship points.
- 3.3. All competitors (Skipper and Crew) shall be a financial member of a club, affiliated to Australian Sailing.

4. FORMAT OF RACING

- 4.1. The Championship series will consist of a maximum of 15 dates across non-consecutive days.
- 4.2. No more than 3 races per on water session will count towards championship score.

5. SCHEDULE OF EVENTS

- 5.1. All days will have up to 3 races and all races will be back to back as soon as possible after the completion of the previous race.
- 5.2. Competitor Briefing not before 1200hrs each race day.
- 5.3. Warning signal not before 1300hrs each race day.

6. SCORING

- 6.1. Four (4) racing days are required to be completed to constitute a series.
- 6.2. When fewer than twelve (12) races have been completed, a boat's series score will be the total of her race scores.
- 6.3. When thirteen (13) to eighteen (18) races have been completed, a boat's series score will be the total of her race scores excluding her three (3) scores.
- 6.4. When nineteen (19) to twenty four (24) races have been completed, a boat's series score will be the total of her race scores excluding her worst six (6) scores.
- 6.5. When twenty five (25) or more races have been completed a boat's series score will be the total of her race scores excluding her worst nine (9) scores.

7. MEASUREMENT

- 7.1. There will be no equipment inspection prior to the racing.
- 7.2. Spot checks on equipment may be made at any time during the series. It is the owner's responsibility to ensure that their boat conforms to the class rules and compliance card requirements throughout the series.

8. SAILING INSTRUCTIONS

- 8.1. Sailing Instructions will be available prior to race day and copies will also be available on the notice board.
- 8.2. Any changes to the Sailing Instructions will be advised at briefing.
- 8.3. All skippers will be required to sign on before leaving the beach and sign off as soon as practicable after returning to the beach.

9. RACING AREA

- 9.1. The racing area will be on the waters of Owen Anchorage off Woodman Point Western Australia, adjacent to Jervoise Bay Sailing Club.

10. COURSES

- 10.1. The courses to be sailed will be windward-leeward courses with race target times of 20-30 minutes.

11. TIME LIMIT

- 1.1. Boats failing to finish within 30 minutes after the first boat sails the course and finishes will be scored Did Not Finish without a hearing. This changes rules 35, A4 and A5.

12. SUPPORT BOATS

- 12.1. If called upon support boats will be required to act as rescue boats.

13. PRIZES

- 13.1. Trophies/Prizes will be awarded to 1st, 2nd and 3rd overall at the end of the series.
- 13.2. Pennants will be awarded to 1st, 2nd and 3rd of each race at the completion of the day's racing.

14. DISCLAIMER OF LIABILITY

- 14.1. It is the competitor's decision to enter the Event or to start and continue in any race. Competitors shall accept that their participation in the Event is at their exclusive risk in every respect. See Rule 4, Decision to Race. The Organising Authority, and the host club, their officers, sponsors, members, servants and agents accept no responsibility in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in this Event or howsoever arising in connection with this Event.

15. INSURANCE

- 15.1. Each Participant shall be insured with valid third-party liability insurance with a minimum cover of AU \$10m per event or equivalent, or as required by class rules.
- 15.2. Proof of current insurance shall be produced at registration.
